Why is it important to protect them?

Mexico has almost 40 million children and teenagers (**NNA, Niñas, Niños y Adolescentes**)



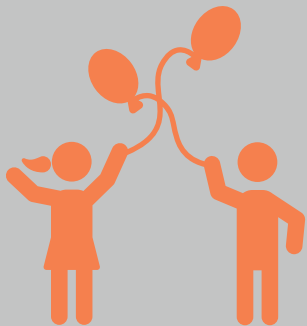
21 million of them live in poverty conditions



3.6 million live in native Mexican homes

The National Integral Protection System for Children and Teenagers (Sistema Nacional de Protección Integral de Niñas, Niños y Adolescentes, SIPINNA) seeks to:

- **Guarantee that children and teenagers hold priority on the rights** they have for an integral wellbeing
- Have authorities, private sector, legislative and judicial bodies follow **this principle**
- Be served before adults in all services, on conditions of **equality**



Among the rights acknowledged by the law on the subject, the outstanding conditions are:



Decision makers

must assess the impact their actions will have on the life of **NNA**

Basic actions in favor of NNA within the context of Civil Protection

- Validate their right to receive protection and assistance during emergencies, under any circumstance on a timely manner



- Include NNA, individuals with special needs, and native Mexicans in programs and protocols, to take their needs into consideration



- Develop civil protection actions from an analysis of risks and behaviors that cause most damage to children and teenagers



National Policy "25 on 25"

25 objectives and goals to be achieved by 2025

One of the objectives it considers:

Protection and perdurance of rights for **NNA, before, during, and after emergency situations** that may risk their lives

The General Law on the Rights of Children and Teenagers (**LGDNNA**) considers actions for the special protection of children and teenagers in vulnerable situations due to problems created by the following conditions:



socioeconomic



dietary / hunger



psychological



physical



disability



cultural
identity

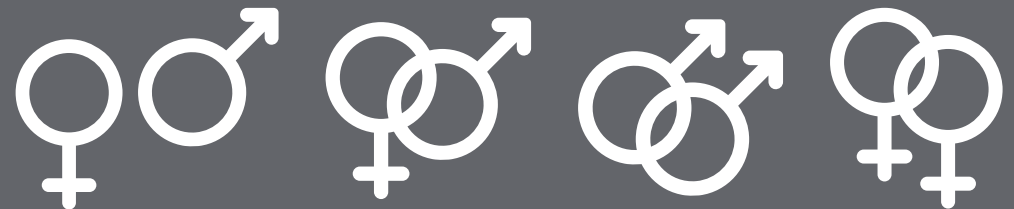
